





EPIS framework: Pilot

- Exploration, Preparation, Implementation, + Sustainability framework used to conduct a holistic evaluation of the Family Recovery Court
- Stage 1: Summer 2022
 - Interviews conducted with 16 professionals + 1 parent graduate of the FRC
 - Focused on process and experiences with implementation
- Stage 2: Summer 2023
 - Interviews with parent graduates + professionals
- Stage 3: Fall 2023
 - Survey administered and completed by n = 22 providers
- Stage 4: Summer 2024
 - Data analysis + ongoing capacity-building
 - Initial *effectiveness*





ASSIGNED ATTORNEY INFORMATION SHEET

Counsel:

You have been assigned preliminarily to a potential participant in the Family Recovery Court program. Your role is to explain the program to the potential participant and to provide legal advice regarding the potential benefits and drawbacks of participation for your client.

A Family Group Conference (FGC) has been or will be scheduled to discuss whether your client is in agreement to be considered for the program. Please meet with them in advance of the FGC. Once the FGC is completed, a Family Recovery Court Team Meeting will be set to decide whether the Team recommends your client for admission to this specialty court program.

If your client is accepted into the program, the case may be transferred to a different court, depending on which court was originally assigned, and your assignment will become an official appointment of the Court. If your client is not accepted into the program, your assignment is completed and you are discharged from any legal relationship with the potential participant.





Parent Voices

I was offered recovery court after multiple CPS cases and just, I wasn't ready to get clean and I actually ended up going to rehab on my own. And then they offered me family recovery court afterwards and that was probably one of the, the family recovery court saved my life. I don't think that I would have succeeded without it. Just going to rehab alone, probably would not have done it for me. I will be 2 years clean in November and that's thanks to all the support with family recovery court, the accountability that they [have], they hold you accountable. You know, you have to go to court dates and see coaches and therapists and all those things combined. Without it, I wouldn't' have been able to be here today, I don't think.
